I would like to thank you for reaching out and giving me the opportunity to answer your questions and concerns. For those of you who don't know me, I have been on council previously. I was a councillor in 2013. I enjoyed helping my fellow citizens, and being part of some developments that took place. My focus is to continuously better Kazabazua and all of its beauty in a harmonious fashion. I want to be of service to the development of Kazabazua and to feel proud of what I accomplish towards my community. I have been a citizen of Kazabazua all my life and have great pride in it.

I helped create a committee as well a few years back, called the Generation of Tomorrow with a few of my friends and this was to help attract families to our community. I am proud to say that with only 5 years of being established, we had fundraised many events for the children to have something to do at Christmas time, during Halloween and Easter as well as Canada Day. In doing so we were able to give back to our community, with helping purchase material for a skate park, purchasing basketball nets, purchasing add ons to the community play park, installing the play structure for free and donating money to the Low Arena. Question 5.1: I know that many permanent and seasonal residents work from Kaz at the moment and internet is essential for them. I believe that Picanoc is the service provided right now and that Bell high speed ends at Lee road. I think if we were to get citizens to sign a petition which indicates the NEED for their high speed service, along with a municipal letter asking them to consider extending their high speed service to a certain area, they may consider it. Bell is continuously extending their internet service and if there is a need for their service and if they can sell more of their packages I am sure they will be willing to do so. I am not aware of any other local internet service so this is why I mention Bell but if there are any other local ones we could try with them as well. With Covid and the lock down situations that have occurred I would hope they would be more comprehensive of our needs and to be able to work from home.
