A Concrete Achievement

In 2021, on my own initiative, I prepared a detailed report on the unsafe conditions of Route 105. This months-long work highlighted:

- Excessive speeding and heavy traffic, more suited to a highway than a rural road
- Major safety risks for users
- Unequal infrastructure investment compared to other regions in Québec

Since submitting this report to the MRC, to our local Member of Parliament, and to the Ministry of Transport on August 25, 2021, repair work has been carried out—most notably new paving in our village. Additional projects followed in other municipalities within the MRC.
